You are invited to submit a proposal for our joint spring conference of rehabilitation professionals, educators, and students in the diverse but united professions of career assessment, job placement, rehabilitation counseling, vocational evaluation, and work adjustment.

Known as “the beach conference”, this statewide conference is held in Atlantic Beach, NC for one and a half days and provides ten CRCC and CVE continuing education credits. The spring conference dates are March 15-16, 2012.

Keeping it Fresh is our spring 2012 conference theme, as we look to the horizon for innovative practices and renewed visions.

Peer-reviewed proposals may be for 90 minute sessions or poster presentations and should include the following:

- 1) Presenter contact information and a brief biography (100 words or less)
- 2) Title and abstract for your presentation (150 words or less)
- 3) Brief description of presentation content (500 words or less)
- 4) Presentation type: (lecture, demonstration, research, conceptual, experiential), 90-minute education session, or two 15-minute poster sessions.
- 5) Briefly describe how your presentation ties into the conference theme
- 6) Briefly describe experience, qualifications or credentials which reflect your expertise for your intended presentation topic.
- 7) Email your proposal submission by December 31, 2011 to Andrew Byrne, NCRCA president: ambyrne@med.unc.edu

Peer-reviewed poster sessions are scheduled for at least two 15-minute periods. Peer-reviewed presenters must register for the conference, provide their own transportation, and secure lodging. For more information go to <http://www.ncrehab.org/id33.html>
